Intended Service:

Watertight cover for marine vessels and offshore installations.

Description:

15" x 23" and 18 ¼"x24 ¼" clear opening, raised, hinged, dogged watertight hatch complete with neoprene gasket forming seal along edge of 3/8" thick coaming 5" high. They are manufactured from ASTM A36 steel or equivalent and 304 Stainless Steel. Hatch cover is 5/16" (7.94 mm) nominal thickness. Four dogs are used to clamp hatch cover shut.

Ratings:

Watertight to a pressure head of 9 ft (2.75 meters).

Service Restrictions:

Unit Certification is not required for this product. If the manufacturer or purchaser request an ABS Certificate for compliance with a specification or standard, the specification or standard, including inspection standards and tolerances, must be clearly defined.

The hatch cover scantlings were reviewed for the pressure heads, as indicated in the Ratings section. For each installation, drawings are to be submitted for review for verification that the materials, arrangements and coaming height and thickness, including closing arrangements are acceptable for the proposed location. The weld procedure for welding the stainless steel coaming with the mild steel deck has to be submitted for review prior to installation. These products are not to be installed on the exposed fore deck within the forward 0.25 L (L is the scantling length of a ship), where the deck in way of the hatch is less than 0.1 L or 22 m (72.2 ft.) above the summer loadline, whichever is less, per ABS SVR 3-2-15/14.
